INFORMATION NOTICE ON THE PROCESSING OF PERSONAL DATA

Paolo Castelli S.p.A., with its registered office in Ozzano (Bo), Via I° Maggio No. 93, VAT No. 00512981200 - Tax Code 00526840376 (hereinafter the "Data Controller"), in its capacity as data controller, informs you pursuant to Article 13 of EU Regulation No. 2016/679 (hereinafter "GDPR") that the data collected will be processed as follows.

Subject, Methods, and Duration of Processing

The processing will concern personal data and will be limited to data strictly relevant and functional to the purposes pursued. Processing may include the collection, registration, organization, storage, consultation, processing, communication, deletion, and destruction of data. Processing may occur manually and/or with the support of computer and telematic tools. The data will be retained for the time necessary to fulfill the purposes of the processing, and in any case, no longer than 10 years after the termination of the contractual relationship, and no longer than 5 years from collection if the data is used for marketing purposes.

Nature and Purpose of Processing

The Data Controller processes personal data during the conclusion or execution of contracts and/or for the purposes of commercial promotion, informative communication, and/or advertising of its products and services or events it promotes or organizes. Personal data is processed without explicit consent to: conclude contracts with the Data Controller, fulfill pre-contractual, contractual, or fiscal obligations arising from existing relationships, comply with legal obligations (national or EU), and follow any orders from authorities; or to exercise the Data Controller's rights. In such cases, data may be communicated to entities to whom disclosure is legally required for the fulfillment of these purposes; these entities will process the data as independent data controllers. With the data subject's specific and separate consent, the data may also be used by the Data Controller for marketing purposes through the sending of emails, SMS, phone calls, newsletters, commercial communications, and/or advertising material. The data subject has the right to notify the Data Controller of their selective consent or denial for specific marketing purposes. Users who choose not to register on the Data Controller's website may still navigate it freely without this affecting any business, contractual, or other types of relationships with the data subject.

Access to Data

Data may be made accessible, for the purposes described above, to the Data Controller's employees and/or collaborators in their capacity as internal data processors and/or system administrators.

Data Transfer

Your personal data is stored on a server located at the Data Controller's premises within the European Union.

Data Subject's Rights

Pursuant to Articles 7 of the Privacy Code and 15 of the GDPR, the data subject has the right to:

- Obtain confirmation of whether or not personal data concerning them exists;
- Receive information on the origin of the personal data, the processing methods and purposes, the use of electronic tools, the identity of the Data Controller, data processors, and any appointed representatives, and the entities or categories of entities to whom the personal data may be communicated or who may become aware of it as designated representatives, processors, or appointees;
- Request the updating, correction, integration, deletion, anonymization, or blocking of data processed unlawfully, including data that does not need to be kept for the purposes for which it was collected or processed;
- Object, for legitimate reasons, to the processing of personal data, as well as to the sending of advertising or direct sales materials or commercial communications, using automated systems and/or traditional marketing methods.

Where applicable, the data subject also has the rights provided for in Articles 16–21 of the GDPR (Right to rectification, right to erasure, right to restriction of processing, right to data portability), as well as the right to lodge a complaint with the Data Protection Authority.

Methods for Exercising Rights
